

# El Paso County Juvenile Justice Data Sheet

Under SB 653, the Texas Juvenile Justice Department (TJJD) has been made responsible for partnering with "local county governments, the courts, and communities to promote public safety," as well as for "producing positive outcomes for youth, families, and communities." To ensure these mandates are met, stakeholders must familiarize themselves with the information pertinent to their community.

The information included within this data sheet reflects the most recent juvenile data for El Paso County.

<sup>&</sup>lt;sup>8</sup> The Intensive Community-Based Program (Grant X) is used by local juvenile probation departments for "enhanced or additional community based programs and services for jailable misdemeanor and felony offenders." In 2011, 8,392 youth were served under Grant X funds; 81% of those youth received treatment via programming. Texas Juvenile Probation Commission, *Annual Report to the Governor and Legislative Budget Board*, December 2011.

<sup>&</sup>lt;sup>9</sup> The Intensive Community-Based Pilot Program (Grant U) is used by local juvenile probation departments with populations over 335,000 to serve youth with chronic and serious offenses via community-based programming. In 2011, 839 youth across eight counties (Bexar, Cameron, Dallas, Denton, El Paso, Harris, Tarrant, and Travis) were served by Grant U funding. Texas Juvenile Probation Commission, Annual Report to the Governor and Legislative Budget Board, December 2011.

<sup>&</sup>lt;sup>13</sup> Inappropriate use of solitary confinement (also known as disciplinary seclusions) and physical restraints (also known as use of force) in juvenile secure facilities create major barriers to successful rehabilitation. These concerns are especially serious for traumatized youth and youth with mental health issues. *See, e.g.,* L.M. Finke "The Use of Seclusion is Not an Evidence-Based Practice" (2001), *and* G.R.
