

# Gaines County Juvenile Justice Data Sheet

Under SB 653, the Texas Juvenile Justice Department (TJJD) has been made responsible for partnering with "local county governments, the courts, and communities to promote public safety," as well as for "producing positive outcomes for youth, families, and communities." To ensure these mandates are met, stakeholders must familiarize themselves with the information pertinent to their community.

The information included within this data sheet reflects the most recent juvenile data for Gaines County.

## County Overview<sup>3</sup>

## **Investment in Community Programming**

Reducing the number of youth adjudicated to residential facilities can only be achieved if stakeholders strongly invest in "a consistent, county-based continuum of effective interventions, supports, and services." Youth who are referred to TJJD from Gaines County are detained (pre-adjudication) in the Garza County Regional Juvenile Center. Separately, post-adjudication placements of youth from Gaines County vary by need and proximity to home.

Inappropriate use of solitary confinement (also known as disciplinary seclusions) and physical restraints (also known as use of force) in juvenile secure facilities create major barriers to successful rehabilitation. These concerns are especially serious for traumatized youth and youth with mental health issues. *See, e.g.*, L.M. Finke "The Use of Seclusion is Not an Evidence-Based Practice" (2001), *and* G.R.
